# 1. Score Microbiology

Guusje Jansen says that someone mentioned that the score of the Safe Microbiological Techniques (SMT) test was changed after a few weeks. You could immediately see your score after finishing the test and she passed then. But, after a few weeks when all the scores became available in Brightspace, it says that she had failed. She also had a complaint about the timing of the grades. In year 2, PTB2 and Microbiology are taught in two consecutive blocks. The students are thus divided into two separate groups. They waited until everyone finished the Microbiology course before they published the grades. So, the people who first took the Microbiology course had to wait for many weeks before they got their grades. Marijke van der Waqt indicates that teachers only have ten working days to check the examens. Guusje says that the students have indicated this to the teacher. She indicates that the main problem is that the score of the SMT test was adjusted afterward because this was the case with several students. She says she does not know if the teacher is aware of this. Boy van Basten states that the staff needs to be clear in the communication. So, the score you see right after finishing the exam is not necessarily the final score. Especially in multiple-choice exams, there are sometimes some corrections afterward. This can change the final score. Guusje says that the teachers should communicate better to the students that the score they see right after finishing the exam is not the final score. They can see that it is just an indication or that you can only see the score and not 'passed' or 'failed'. Jesse Mulder is wondering how we can reach all the teachers because he thinks that this is not the only course with this problem. Katja Taxis mentions that you can also switch off the option to show the score to the students. She is wondering if every teacher is aware of what students can see right after an exam. Boy says he asks a colleague, he enrols that colleague as a student in the course so he can check what the exam looks like as a student. Yael Benjamins says she writes a disclaimer above the exam that says you can only see the score but afterward she will let you know if you passed or failed the exam. Frank Dekker says that this problem should be raised with all examiners. Renske Vonk says she will ask Monique Smith to send an email to all the examiners so that the communication from the teacher to the student during an exam improves.

# c. Bsc. Pharmacy Year 3

### 1. Organic Chemistry Practical

Kai Timmer is wondering what results came out of the discussion between the program director, the study advisors, and the coordinator of the course. Jesse Mulder indicates that Herman Woerdenbag has let us know that, as mentioned above, the exam will be before the Christmas holiday next year. Katja Taxis says that there will be a new Chemistry teacher. Myrthe Boerrigter asks if this is dr. Szymanski. Katja Taxis says that he will indeed be the new teacher.

# d. Msc. Pharmacy Year 1

#### 1. Communication FPZ

Emma van Rijn says that there were some complaints, especially related to the feedback on the article they had to write. The feedback was quite unclear because sometimes the feedback says the students must change everything and then when you mailed back it was like 'Oh, you just need to change this'. Wies van Bakel says the communication is unclear for this part. You must ask further for more information. If the communication is better, that will save a lot of extra questions. Emma adds that there is a lot of difference in which teacher grades your work. Yael Benjamins says she understands the problem. Brightspace does not explain very clearly how it works with the grades, this should be improved. She indicates that they always try to keep the grading objective and the teachers also check each other's assessments. However, this does not happen every time. She says it may seem that some teachers are stricter, but students can always email if their assessment is not clear. Emma says that

students often email, but then the feedback is different than what is stated on Brightspace. *Myrthe Boerrigter* wonders whether the teachers themselves have also noticed that some teachers check more strictly. *Yael* says this is not the case, but she also indicates that there will be a sounding board with the course coordinator. She says that students should also report the problems there. *Emma* says that there are already students participating in the sounding board. *Jesse Mulder* emphasizes that the students must report it if no solution has been found after the sounding board.

### f. Msc. Pharmacy Year 3

#### 1. Specialistische Farmacotherapie

Jesse Mulder says there is a complaint about the exam. The exam was planned for the 28<sup>th</sup> of April at 14:00h. Then there was a poll to reschedule the exam to the next week because otherwise it was planned on the day after Kings day. Too many people still wanted the exam on the 28<sup>th</sup> of April, so the exam was not rescheduled. But then the exam was moved, without consultation and notice, to 9:00h, because otherwise no invigilator could be present. Katja Taxis explains that she does not do the scheduling by herself, and she realized too late that the exam was scheduled that day. 2/3 of the reactions of the poll wanted to have the date moved but 1/3 did not want it. Because the 28<sup>th</sup> of April was the original date it was not rescheduled. She says she understands the problem, but there was no other solution. Myrthe Boerrigter says there was also a problem with the foreign trip which is planned for the week before the exam. She noticed that last year it was discussed at the RVA about arrange seeming about the planning. Katja says that the schedulers always take last year's schedule, and she realized it too late. This year the schedule came in batches. Hopefully, next year the schedule is known in September because then things can change. When you realize in January, like this year, it is too late to reschedule exams.
